PORT ASSOCIATED STAFF MEMBERSHIP RULES AND SUBSCRIPTION RATES

Please note that your membership is due for renewal on 1st April each year, no matter what part of the year you joined, if you do not rejoin by 1st May each year you will then need to be renominated.

PORT ASSOCIATED STAFF - means

Persons who are not employed by the Dover Harbour Board but have a Port related job association. Only Dover Harbour Board employees who are also fully paid up members of CLUB DOVER (the DHB Sports & Social Club) can nominate Port Associated Staff to join. Port Associated Staff members **cannot** nominate other persons to become members of CLUB DOVER (the DHB Sports & Social Club).

Please note:

Family membership includes the member's partner or spouse and all immediate family members under the age of **18** years.

Associate members of any class **DO NOT** have any voting rights in the DHB Sports & Social Club.

This membership does not include membership of the Gym, but as a member of CLUB DOVER (the DHB Sports & Social Club) the Gym facilities can be used after induction and payment of the appropriate subscription.

GYM INFORMATION:-

Payment for the gym facilities can be made by Standing Order or per session:

- Induction £12.00 (all persons to have induction before use of Gym facilities)
- £ 4.50 per session; or
- £16.00 per month single membership; or
- £25.00 per month family membership
